## RULES AND REGULATIONS

# WALK HUNT CHALLENGE



1. Walk Hunt Challenge is a drive and walk event.
2. A Team shall be made up of minimum 2 members to a maximum of 4 members per car excluding children below 12 years old. The driver of the car should possess a valid driving license and the car entered must be road worthy and have a valid road tax and insurance.
3. Participants below 18 years of age must have at least one team member who is above 18 years old at the time of event.
4. The Hunt is not a race. All traffic rules and private premises restrictions apply throughout the event.
5. All registration forms must be duly completed with payment. Entries will be on a first-come-first-serve basis at the discretion of the Organiser. Whilst fairness will be exercised, the Organiser reserves the right to reject any entry without explanation. Entry fees paid are not refundable.
6. The date and venue for the Hunt briefing will be announced later. At least one team member from each team MUST attend the Hunt Briefing. He/She/They shall be responsible for disseminating all information provided at the Hunt briefing to all other team members.
7. Competition numbers and other stickers of the sponsors must be placed as instructed by the Organiser and remain on the vehicle throughout the Hunt. No other stickers or forms of advertising other than those provided by the Organiser shall be permitted. The Organiser reserves the right to impose penalty points or disqualify teams for failure to do so.
8. The Organiser reserves the right to amend the rules or change or postpone the date, or cancel the event if it is deemed necessary. In the event of a cancellation, reimbursement of registration fee will be made accordingly.
9. The Organiser also reserves the right to disqualify or impose penalty points to teams found to have supplied false information in the Registration Form or collaborated or cheated in the Hunt.
10. All materials of whatsoever nature in relation to the Hunt shall belong to and used by the Organiser for publicity purpose.
11. All treasure items submitted in the Hunt shall belong to the Organiser and no team shall have a claim to them.
12. The winner is the team which scores the highest number of point, with subsequent positions determined accordingly. In the event of a tie, tie-breakers will be applied, and these will be made known at briefing session.
13. All decisions of the Organiser in all matters of the event shall be final and binding on all participants.
